The Director, Social Welfare, Jharkhand, Ranchi hereby invites in the prescribed format sealed bids from manufacturers (reputed and experienced Self Help Groups, Mahila Mandals, Village Communities and Manufacturers) for procurement of Micronutrient Fortified Food/Energy Dense Food as per Schedule of Requirements on rate contract basis through 3 envelope system. The supply shall be as per the approved 2 (two) recipe as mentioned in the bidding document i.e. Fortified Panjiri and Upma respectively. The rates are to be quoted for Micronutrient Fortified Food/Energy Dense Food accordingly and separately.
